On behalf of the Board of Health, I am pleased to provide you with our 2018 Annual Report of activities conducted by the Mount Olive Township Health Department. Inside you will find highlights from 2018, a detailed breakdown of the activities conducted by each of the Department's divisions, and goals and objectives for 2019.

Some of the highlights from 2018 include the launching of the Mt. Olive Health Improvement Coalition, a group of 30 community partners, who share our vision of healthy people, making healthy choices, in a healthy environment. The group began the process of developing a Community Health Assessment. Other highlights included, doubling the number of senior medical transports over 2016, working with the NJDEP to address the hazardous algae blooms in Budd Lake, providing health screenings to over 400 residents, welcoming new Board member, Laura Hawkins, and vaccinating 440 dogs and cats against rabies.

We have exciting things planned as we move into 2019. These include publishing our first community health assessment and beginning to work on a community health improvement plan with our many public health partners. We will also continue working on our workforce development, quality improvement, strategic planning, and performance management efforts. These activities will assure us success as we prepare for and apply for national accreditation in late 2019.

The Board and Department are committed to providing services and programs that are consistent with our mission to ensure the highest quality of life for our residents. Your comments and suggestions on our efforts to improve access to important health information and services are encouraged.

We thank you and our many public health partners for your continued support as we continue to strive to deliver you the best public health services available. We hope you find this Annual Report to be of interest and value.



# WHAT Is PUBLIC HEALTH?

Public health promotes and protects the health of people and the communities where they live, learn, work and play.

Public health works to assure the conditions in which people can be healthy. This includes:

- Vaccinating children and adults.
- Educating people about the risks certain behaviors can have on your health.
- Setting safety standards.
- Tracking disease outbreaks.
- Preventing injuries in all environments like school and work.
- Creating laws that promote healthy environments.



# 2018 HIGHLIGHTS



### **ADMINISTRATION**

- Served as a resource to Town government by translating for deaf residents
- Distributed gifts to 50 children of 24 families for holiday gift program
- Distributed over 60 donated gift cards to needy individuals
- Promoted Public Health as a career choice by hosting three interns from local colleges
- Created the Mt. Olive Health Improvement Coalition to begin work on a community health needs assessment and improvement plan

### ANIMAL CONTROL

- Investigated 13 cruelty allegations with 11 resulting in direct action, including one indictment
- Investigated over 50 animal bite cases, referring nine individuals for emergency post exposure treatment
- Held two free rabies clinics, vaccinating over 400 pets
- Took possession of a new animal control van

### **ENVIRONMENTAL HEALTH**

- Educated public pool operators/owners on changes to State bathing code
- Initiated protocol for surveillance and response to harmful algae blooms on Budd Lake
- Hired a new Registered Environmental Health Specialist to fill the vacancy left by our retiring Chief Environmental Health Specialist of 39 years
- Advised State Health Department on changes to the retail food establishment regulations

### **NURSING**

- Investigated over 230 reports of potential infectious diseases to prevent their spread in the community
- Over 400 residents benefited from free and low-cost clinics and health screenings
- Administered 577 influenza vaccinations
- Investigated three incidents of measles exposures on travelers from flights into Newark International Airport

# 2018 HIGHLIGHTS



### **HEALTH EDUCATION**

- Participated in monthly "Local Lives" radio segment on WRNJ Radio. Each live segment featured the health topic of the month, including sun safety, nutrition, and Lyme disease
- Created monthly health education posters that were posted in public locations around the Township
- Conducted key informant interviews and focus groups with township residents to understand the health needs of Mount Olive

### SENIOR TRANSPORTATION

- More than doubled the number of medical transports for seniors compared to 2016
- 58 new seniors signed up for transportation services
- Applied for NJ Transit grant for \$100,000 in operating capital and a new handicap accessible van
- Hosted the 42nd annual Township Senior Picnic



# **ACCREDITATION**

The Mount Olive Health Department started the accreditation process in 2017 and has been working diligently toward accreditation with hopes to apply for accreditation in December 2019.

Accreditation provides is a status that public notification that institution, an program, or agency meets standards of quality set forth by an accrediting agency. The accreditation process reflects the fact that the institution, agency or program is committed to self-study and external review by one's peers. Accreditation has been widely accepted by many fields in the U.S. including healthcare system, schools, and social service such police agencies as and fire departments. Likewise, public health agencies need to demonstrate their accountability to agency their community, and measure against nationally identified performance standards.

The Public Health Accreditation Board (PHAB), is nonprofit organization dedicated advancing the quality and performance of state, local, tribal, and territorial public health departments by providing a national framework of standards. PHAB has a vision of improving the quality and performance of all health departments in the U.S. through voluntary accreditation. The PHAB voluntary accreditation emphasizes program importance of and is grounded in quality catalyzed health improvement, and has this department activity in area. The process of preparing for and achieving accreditation yields information about the agency that can be used to identify areas of improvement. accredited, health Once departments maintain their status for 5 years.

The main component of the accreditation process is the documentation selection process, based on a set of standards and measures. These standards measure overall agency capacity. They include 12 Domains:

Domain 1: Conduct and disseminate assessments focused on population health status

Domain 2: Investigate health problems and environmental public health hazards to protect the community

Domain 3: Inform and educate about public health issues and functions

Domain 4: Engage with the community to identify and address health problems

Domain 5: Develop public health policies and plans

Domain 6: Enforce public health laws and regulations

Domain 7: Promote strategies to improve access to healthcare services

Domain 8: Maintain a competent public health workforce

Domain 9: Evaluate and continuously improve processes, programs, and interventions

Domain 10: Contribute to and apply the evidence base of public health

Domain 11: Maintain administrative and management capacity

Domain 12: Maintain capacity to engage the public health governing entity

# **QUALITY IMPROVEMENT**

Quality improvement in public health is the use of a deliberate and defined improvement process, such as the Plan-Do-Study-Act (PDSA) process, which is focused on activities that are responsive to community needs and improving population health. It refers to a continuous and ongoing effort to achieve measurable improvements in the efficiency, performance, accountability, outcomes, and other indicators of quality in services or processes which achieve equity and improve the health of the community. The Mount Olive Health Department developed its first QI Plan in 2017. The plan describes the Health Department's approach in choosing quality improvement projects, with staff members submitting project ideas, and the QI Team vetting the project with a project selection worksheet that guides the group in deciding whether a project is worth selecting. The QI Team then uses the PDSA process to work through the improvement project. There were 2 QI projects started in 2018 shown in the chart below:

# ANIMAL CONTROL

The Animal Control Officers at the Mount Olive Health Department enforce local and state laws concerning the care and treatment of animals and educate the public about animal safety. Officers often respond to calls from citizens about stray animals and suspected animal cruelty. Sometimes, officers have to capture or rescue animals, but other times administer warnings or citations to citizens suspected of animal cruelty and mistreatment. Animal Control Officers also ensure that all dogs and cats living in the Township are licensed. The Health Department offers free rabies clinics to ensure that your pet has the proper protection against the threat of rabies.

The Environmental Health division is staffed by Registered Environmental Health Specialists licensed by the NJ Department of Health. They are responsible for protecting the health and well-being of the residents of Mount Olive by enforcing local, state, and federal regulations that pertain to the sanitation of food and water, handling of hazardous and infectious wastes, the safe and sanitary operation of campgrounds, youth camps, massage parlors, tattoo parlors, public swimming pools, wells, septic systems, apartment complexes, kennels, and institutional environments.

# MOUNT OLIVE HEALTH IMPROVEMENT COALITION

In April 2018, the Health Department established the Mount Olive Health Improvement Coalition, a group of Mount Olive residents, organizations and businesses with a stake in the health and wellbeing of the community. The Coalition's purpose is to create a Community Health Improvement Plan utilizing the Community Voice Survey data, various forms of qualitative data collection, and existing Morris County health data. The improvement plan will include programs, events and health promotion activities for the Township.

### The Goals of the Coalition are:

- 1. To leverage existing resources for Mount Olive to work toward a Community Health Assessment and Improvement Plan.
- 2. To utilize data-informed decision making in health policies and programs in Mount Olive.
- 3. To build a collaborative of health professionals, residents, and organizations committed to improving the health and wellbeing of the

Township of Mount Olive.

### 2018 Accomplishments:

- Collected Assessment Data from 386 Mount Olive residents.
- Conducted 11 key informant interviews with key township stakeholders.
- Conducted 3 focus groups of residents.
- Brought together a group of over 30 community members and organizations with an interest in improving the health of the Township.
